- 1. Go through the e-learning CSB (duration +/- 2 hours), access for students outside Radboudumc: here. This e-learning can be completed by yourself at any given time. You have until 1 June 2024 to complete it.
- 2. Go to the eBROK (tab 'Calendar') and enroll for the e-learning CSB with (latest) date 1 June 2024. This is a fictional date, but necessary to record your completion of the CSM administratively. If you are already enrolled for this date, you do not need to do anything.

If these 2 points above are met, your attendance will be visible in the eBROK (within 1 week).

The BROK® coordinator may grant a grace period if there are compelling reasons for not renewing registration in time. Otherwise: retake entire course at a reduced rate of €275 (no Center Specific Meeting (CSM), redo the exam).

**Between 3 and 6 months expired:** fill out a grace request during registration. The Executive Board of the BROK® committee may grant a grace period if there are compelling reasons for not renewing registration in time. Otherwise: retake entire course at a reduced rate of €275 (no Center Specific Meeting (CSM), redo the exam).

# **Frequently Asked Questions (FAQ)**

Do I have to take the BROK course? You can find the answer to this question in the Policy guideline on training.

I completed the CSM e-learning, but I don't see my attendance in the eBROK? Within 1 week, your attendance will be registered by the BROK coordinator.

**How can I schedule an online exam?** You can schedule an exam within the <u>eBROK</u>. Then go to the 'Calendar' tab. Select 'proctoring' to schedule an online exam.

**How can I reschedule my exam?** You can change your exam date in the <u>eBROK</u> under the 'Calendar' tab. Please note! From 9 days before the exam, changing the exam date is not possible.

I have completed the BROK course (or re-registration), but have not yet received a (new) certificate? Once you have met the specific requirements (see previous pages) you will receive a certificate (by e-mail) from the EMWO Examination Office. Your certification will then also be automatically updated in the <u>BROK register</u>. Please note: this may take some time! In case of a proctoring exam, it may take 4 weeks before you receive the certificate (by e-mail). This has to do with the assessment of the proctor video footage.

Will I receive a reminder when my BROK certificate expires? No automatic reminder is sent when the certification is about to expire. If you do want to receive a reminder, record your certificate in the 'Kwaliteitspaspoort' by following this <u>instruction</u>.

I receive a notification from the eBROK environment that access to the eBROK environment is about to expire, now I can take out an annual subscription. What is the advantage? If you have not succeeded in passing the exam within one year you can extend access by purchasing another year's subscription. Purchasing a subscription ensures that you maintain access to the latest material and stay well-informed of new developments. It is not required or necessary to purchase a subscription for the purpose of keeping your BROK certification valid (see also below).

**How do I keep my BROK certificate valid?** To keep your certificate valid, once every 3 years - shortly before the registration expires - you must purchase and complete the re-registration module (see page 2 of this document). You do not need to purchase an annual subscription (see question above) nor do you need to continuously keep the completion of the basic and in-depth modules at 100%.
