

Internal review KWF grant applications 2019



From 2016 onwards KWF has changed the funding framework. KWF has the ambition to bring more results from scientific research into practical applications for patients and the general population. Within this new [Program Research & Implementation](#), KWF is funding research with more focus on the entire development cycle; in other words, from fundamental idea to implementing practical applications for (potential) patients and caregivers.

In agreement with the existing policy, the research board and the Radboudumc Centre for Oncology have decided to continue with the mandatory internal review procedure for KWF grant applications. The internal review of KWF project proposals is meant to improve the quality of the proposals and, thereby, to raise the chance of being awarded. The internal review procedure is in place for all types of projects.

The internal KWF committee consists of prof.dr. A. Geurts van Kessel (chair), prof.dr. Theo de Witte, prof.dr. Hans Kaanders, prof.dr. Iris Nagtegaal, prof.dr. Joop Jansen, dr. Sita Vermeulen, dr. Robert Takes, dr. Niven Mehra, dr. Erik Aarntzen, dr. Julia van Tol, dr. Romana Netea and dr. Paul Span. The scientific secretary of the committee is dr. Dagmar Eleveld-Trancikova.

The adherence to the following time schedule is of crucial importance. **Because of the tight time schedule any project application received after the internal deadlines will not be processed, but automatically postponed to the next round. To value the work of internal reviewers, any incomplete project applications will be postponed as well.**

The upcoming KWF submission deadline in **2019** is **05-06** at **12.00!**


Please be aware the **pre-application** deadline in case of **Infrastructure initiatives (06-03-2019 at 12.00;** pre-submission opens 04-02-2019)

Ultimately 8 weeks before the deadline:

Registration of the new application by sending the first page of the project (containing the title of the project, the summary, the name(s) and affiliations of the principal investigator(s), the purpose, the plan of investigation and the possible results/relevance) to the internal KWF-committee by e-mail to dr. Dagmar Eleveld-Trancikova* (for details, see below). Please include suggestions for at least 2 internal reviewers.

- **Ultimately 5 weeks before the deadline:**
Submission of the 'final' version of the full application to the internal KWF committee*
- **Ultimately 3 weeks before the deadline:**
The applicant receives the written comments/suggestions of the internal reviewers from the internal KWF committee*
- **Ultimately 2 weeks before the deadline:**
Submission of the adapted full application based on the comments/suggestions of the reviewers and the point-to-point reply by the applicant to the internal KWF committee*
- **Ultimately 1 week before the deadline:**
The internal KWF committee will inform the applicant about the final advice.
- Submission takes place through **Grant Management System (KWF-GMS;** does not work in Explorer, choose another browser like Google Chrome!). Be aware, you need to upload your profile ahead, the system performs the *"Eligibility Quiz"* to advise the project proposal types you may apply for.
